SPECIAL CONDITIONS

1. SCOPE OF WORK: (As per BIS norm / standards)

To conduct day to day sampling & analysis work of Iron Ore finished products (Crushed CLO, Screened 10-40mm, Crushed fines & screened fines & stack sampling etc) at our Bagiaburu Iorn Ore Mines, 21.52 Ha. Area.
