



- b. The Company had partially complied with applicable SEBI Regulations and DPE guidelines on Corporate Governance. The Company is a shell Company as per Annual report for FY 2020-21.
- c. The financial results of its subsidiary namely The Borrea Coal Company Limited and its associates The Burrakur Coal Company Limited and The Karanpura Development Company Limited were not consolidated as these Companies were under liquidation / struck off.
- d. The Company had appointed an Internal Audit Cell for conducting the Internal Audit as per Section 138 which consists of Internal employees of the Company and employees of the Holding Company Rashtriya Ispat Nigam Ltd (RINL). Therefore, Form MGT 14 for appointment of internal auditors as required u/s 179 r/w Section 117 of the Companies Act 2013 read with relevant rules applicable thereon has been filed by Ultimate Holding Company RINL. The Internal Audit for the financial year 2018-2019, 2019-20 & 2020-21 has not been conducted as per Annual Report for FY 2020-21.
- e. As informed, the Company has responded appropriately to notices received from various statutory /regulatory authorities including initiating actions for corrective measures, wherever found necessary.
- f. As per annual report as on 31.03.2021, the Company could not comply with RBI revised Guidelines issued for NBFC.
